## 2. Explaination of the variance of the business in 2024 compared to the same 2023:

- In the separate financial statement: Profit after tax in 2024 decreased by 69,758 million VND compared to 2023, equivalent to 56%, mainly caused by the following reasons:

+) In 2024, revenue of the Company from business activities decreased by 470,683 million VND over the same period of 2023, equivalent to 36%. As a result, gross profit also decreased by 39,942million VND over the same period of 2023, equivalent to 50%.

- +) General and administrative expenses in 2024 increased by 66,448 million VND compared to the same period, equipvalent to 128%, caused by converting provision for bad debts in 2023. Therein: converting amount related to the Management Board of Son La Hydropower Project of 1,000 million VND and the CMC/ITD/Song Da Joint Venture of 55,850 million VND.
- +) Revenue from financial activities in 2024 decreased over the same period by 22,103 million VND, equivalent to 26%. The reason is that in 2023, the Company had a profit from securities investment of 24,352 million VND.
- In the Consolidated Financial Statements: the post-tax profit in 2024 decreased compared to 2023 by 63,849 million VND, equivalent to 59%, mainly caused by the following reasons:
  - +) General and administrative expenses in 2024 increased by 71,859 million VND compared to the same period, equipvalent to 588%, caused by converting provision for bad debts in 2023. Therein: converting amount related to the Management Board of Son La Hydropower Project of 1,000 million VND and the CMC/ITD/Song Da Joint Venture of 55,850 million VND.
  - +) Revenue from financial activities in 2024 decreased over the same period by 20,811 million VND, equivalent to 35%. The reason is that in 2023, the Company had a profit from securities investment of 24,352 million VND.
