2. Explanation of fluctuations in business performance in the quarter I/2025 compared to the same period:

- In the separate financial statement: Profit after tax in the quarter I/2025 decreased by 33,634 million VND compared to the quarter I/2024, equivalent to 87%, mainly caused by the following reasons:

- +) Financial revenue in the first quarter of 2025 decreased by 47,134 million VND, equivalent to 97% compared to the first quarter of 2024, In the first quarter of 2024, the Company received dividends from SCI Nghe An Joint Stock Company and incurred exchange rate difference profits.
- In the Consolidated Financial Statement: In the first quarter of 2025, consolidated profit after tax decreased over the same period by 19,617 million VND, equivalent to 72%, mainly caused by the following reasons:
 - +) Financial revenue decreased by 8,512 million VND, equivalent to 59% compared to the same period last year, The main reason was due to exchange rate difference profit.
 - +) Other income decreased by 24,941 million VND, equivalent to 96% compared to the same period, The reason is that in the first quarter of 2024, SCI E&C Joint Stock Company (Subsidiary) reversed project warranty provisions after the warranty period ended.

The above is an explanation of the SCI Joint Stock Company, We look forward to the timely support from the Commission and the Department.
